TENDER SCHEDULE FOR HIRING OF VEHICLE FOR JAWAHAR NAVODAYA VIDYALAYA, CHETTACHAL (PO), VITHURA, TRIVANDRUM (DIST.)

Sealed tenders are invited for hiring of vehicle model 2016 and above, diesel, preferably TATA Sumo Gold/TATA SPACIO/BOLERO, etc efficient good running condition for Jawahar Navodaya Vidyalaya, Chettachal (PO), Vithura, Trivandrum.

Tenders should be sent under strong sealed cover marked as “Tender for hire of Vehicle”. The tenders will be opened in the office of the Principal, JNV by a committee constituted for this purpose on 09/01/2018 at 11.00 AM and successful tenderer will be intimated after scrutiny/approval of the Competent Authority i.e., Deputy Commissioner, Navodaya Vidyalaya Samiti, Hyderabad Region.

The tenders shall be submitted according to the terms and conditions appended herewith. Unless specified otherwise in the tender, it shall be construed that the terms and conditions stipulated hereunder have been agreed to.

TERMS & CONDITIONS :

1. The rate quoted should include all forms of taxes/charges and the rate should be quoted in the prescribed format attached herewith as Annexure I.
2. The duly filled in tender forms should be accompanied by a non-interest bearing refundable EMD of Rs.10,000/- (Rupees Ten thousand only) in the form of a Demand Draft drawn in favour of Jawahar Navodaya Vidyalaya, payable at SBI, Vithura Branch IFSCCode-SBIN0070214. The EMD in cash/cheque is not acceptable and the EMD amount will be converted as security deposit for lowest tenderer.
3. There should not be any over-writings or corrections in the tender. If a figure is to be amended, it should be neatly scored out, the revised figure written above and the same attested with full signature and date. In the absence of the attested signature and date the tender is liable to be rejected.
4. The JNV does not bind itself to accept the lowest tender and reserves the right to accept or reject the tender in whole or in part, as it may decide. No further correspondence will be entertained in this regard.
5. Tender forms shall not be accepted if it is found incomplete and without the required earnest money deposit by demand draft as mentioned above.
6. On acceptance of the tender it will become a contract and the contractor shall be bound by the terms and conditions of the tender.
7. The vehicle shall be hired on 24 hour basis for a period of 10 months in a year (excluding vacation period i.e., April & May) of Jawahar Navodaya Vidyalaya.
8. The contract will be for a period of two years.

9. The vehicle to be hired should be vehicle model 2016 and above, TATA Sumo Gold TATA SPACIO/BOLERO etc which is in proper efficient good running condition.
10. Vehicle is to be hired along with driver from the owner of the company.
11. JNV will bear only the cost of diesel for the distance actually plied for official use for which a log book will be maintained by the driver and Principal will certify the same. All other liabilities including wages of driver, oil and lubricants, maintenance, repair, replacement of parts and servicing, obligations on account of motor vehicle act and other related acts like Labour Laws, road tax, insurance laws (like insurance of vehicles in accident, theft, fire etc.) shall be the sole responsibility of the owner of the company.
12. Rates are invited on yearly basis for a period of 10 months in a year.
13. Payments will be made out of contingency grant of Vidyalaya on a monthly basis.
14. Vehicle will be parked in the Vidyalaya premises only at the risk of the owner of the company.
15. The driver of the Vehicle can be provided accommodation wherever possible subject to availability of accommodation otherwise the arrangements will be made by the owner of the company. Driver of the Vehicle will be allowed to avail mess facility of the Vidyalaya for food purposes only on payment basis as per Samiti's rules.
16. Maximum one day per month i.e., 10 days in a year shall be permitted for maintenance/servicing. The vehicle shall not be sent for repairs for more than four days at a stretch. Alternate vehicles shall be provided by the owner in case the non-availability is for the period exceeding the specified period mentioned above. Failure to provide alternate vehicle shall lead to recovery of actual hiring charges per day.
17. Use of the vehicle will be restricted as per guidelines of Samiti and for Vidyalaya purpose only.
18. Owner of the Company shall furnish a refundable security deposit of Rs.10,000/- (non-interest bearing) with the Vidyalaya at the time of execution of agreement (as mentioned at sl.no.2 above).
19. The owner of the company shall be responsible for efficient and diligent services. If the service is not found satisfactory, the Principal, Jawahar Navodaya Vidyalaya, Chettachal (PO), Vithura, Trivandrum will be at the liberty to cancel the contract at any time without prior notice to the owner of the same.
20. The owner of the Company shall be responsible for proper conduct of the driver. He will have to change the driver in case the driver's conduct being reported as improper by the Principal of JNV. The Principal, Jawahar Navodaya Vidyalaya, Chettachal (PO), Vithura, Trivandrum will be at liberty to cancel the contract on this ground also. i.e., in case the conduct of the driver is found unsatisfactory without any prior notice of the same to the owner of the Company. Police verification of the driver is an essential condition and his continuation shall be subject to good antecedents and character.
21. The lowest bidder shall have to execute a contract with the Principal, Jawahar Navodaya Vidyalaya, Chettachal (PO), Vithura, Trivandrum.
